LETTER FROM THE RECTOR

"It was impossible not to feel the Holy Spirit." That's how one member described her experience at an indoor skate park, and she was not alone. She was one of hundreds of volunteers who participated in a herculean grassroots effort to resurrect and reinvigorate an abandoned church building. Over the span of 12 years, hundreds of volunteers – mostly young people – filled dumpsters with debris, shoveled the remains of dead animals, and fortified failing structures. In the end, St. Liborious Catholic Church, "the largest gothic revival church west of the Mississippi," became Sk8 Liborious, an indoor skate park and outreach organization in St. Louis.

Tragically, Sk8 Liborious made national news last summer when an electric fire consumed the roof, leaving their building partially intact but otherwise ruined. "Before the four-alarm fire, Sk8 Liborius was a beautiful place in a place not known for beauty." To be sure, it was a form of beauty easily overlooked because it was more about the people than their property. Sk8 Liborious "was a place where people could feel safe and be free" in a context where both were in short supply. Now, seven months after the fire, they're still figuring out their options but they plan to rebuild. How could they not? "After all," they suggested, "who but us is interested in making our particular patch of unwanted earth more beautiful?"

Who but us? It's a question brimming with possibility for St. John – and not because we're lacking in beauty. Far from it. Rather, it's a question brimming with possibility because we're members of a living community with a centuries-old legacy of Christian worship and mission here in York. The question inherited by every generation of believers is the same: Who but us? Who but us is going to faithfully steward the gifts – both spiritual and material – that we have received? Who but us is going to faithfully discern adaptive initiatives that speak to the changing longings and needs of our neighbors? Who but us is going to faithfully embody the enduring light of Christ in our particular patch of earth? Who but us?

As we look over the past year, it's encouraging to consider the many ways that we have leaned into that question. We have faithfully stewarded our gifts, from a refurbished historic entrance to our renewed Memorial Garden. We have faithfully discerned opportunities to serve our neighbors, from stable partnerships in local outreach to potential initiatives for urban agriculture. We have faithfully embodied the light of Christ through our worship and relationships, rejoicing with those who rejoice and weeping with those who weep (Rom. 12:15).

In the coming year, let's allow that question - *Who but us?* - to continue guiding our stewardship, discernment, and witness. Let's also remember that we are never alone in our work, because the same Christ who commissions us also accompanies us every step of the way. We can rest assured that as we seek to be faithful, it will be impossible not to feel the Holy Spirit guiding our way.

MINUTES OF THE 2023 ANNUAL MEETING (YEAR-END 2022)

III. Confirmation of Quorum

60+ confirmed in attendance which is more than 50% of the average of the last two annual meetings, constituting a quorum.

IV. Certification of Minutes of the 2022 Annual Meeting.

A motion was made by Linda Davidson and seconded by Barb Linder to approve the minutes as presented. Unanimously approved.

V. Report of the Nominating Committee

Steve Linebaugh

- A. The 2022 nominating committee was comprised of Steve Linebaugh, Daniel Blakemore, Susan Ariail, Anne Strayer and Kendall Menzer.
- B. Vestry Nominees Mike Dellinger, Scott Hamilton, Pete Partridge, Felicia Marino, Kris Potter Klouse and David Kierce. Unanimously approved.
- C. Nominating Committee for 2023- Bill Ariail and Carolyn Warman.
 - 1) A motion by Anne Deisher and seconded by Matt Conant was made to accept the nominees for 2023. Unanimously approved.
- D. Father Eric asked for volunteers to represent St. John at the Diocesan Convention in the fall of 2023 with Charlie Marinio, Milton Leake, Susan Leake and Dorothy Kennedy volunteering. A motion by Eric Menzer, seconded by Wanda Linebaugh, to accept them as nominees was made. Unanimously approved.

VI. Rector's Report

The Rev. Eric Hillegas

- A. Father Eric asked that his report be accepted as presented in the annual report and then invited Mother Alyssa and Ivan Ruiz share highlights from their ministry areas in 2022.
- B. Mother Alyssa cited advances in Godly Play, Spiritual Retreats and Expanded Liturgies.
- C. Ivan cited his increased role as Office Administrator along with Adult Forum, Pilgrimage, Home Blessings and monthly Nourishing Soul and Body which he hopes to continue in 2023.

VII. Senior Warden's Report

Daniel Blakemore

- A. The Icons in Transformation exhibit was a highlight of 2022 with over 300 visitors coming to St. John to view the exhibit. Earnings from the exhibit supported our ministry to Haitian migrants as well as (pending) repairs and painting of the church interior.
- B. The church furnace failed in December of 2021, necessitating its replacement. Since the air conditioning system was also near the end of its useful life, the vestry elected to replace both systems with a combination HVAC system which is scheduled to be fully installed by the end of February 2023.
- C. A non-binding agreement for the church to be involved in discussions about the development of our parking lot was signed in 2022 but the development project for Northwest Triangle was not accepted by the City of York so the non-binding agreement is now null and void.
- D. Brockie Realty/Healthcare who leases the church-owned parking lot has contracted with a new app-based revenue collection vendor by the name of ParkPoolr. St. John members who want to use the lot for church business during business hours are asked to provide their license plate information to the St. John office before April 1, 2023 to continue with free parking.

VIII. Junior Warden's Report

Morgan Hively

- A. The installation of the new HVAC system is nearing completion.
- B. Painting will follow the installation of the new HVAC system.
- C. Brick repairs on the south alley side of the church to seal and replace mortar in March/April.
- D. Phase One audio/visual system upgrade in the rear of the church which was paid for by private donations will be a good first step in making our online streaming and in-house audio more reliable.

VIV. Treasurer's Report

David Hogeman

- A. There was a cash surplus in 2022 of \$48,935 with income exceeding expenses which will support our new HVAC system in 2023.
- B. The Vestry has approved a balanced budget for 2023, for the 6th year in a row.
- C. We have paid down approximately \$900,000 on our \$2.4 million mortgage. Current mortgage funds will be exhausted in August of 2026, at which time our remaining balance would be approximately \$1.2 million. The Vestry will be looking for ways to raise funds necessary to continue the payment of the mortgage until completion.

X. Finance Committee Report

Liz Wright

- A. We currently have \$803,000 in investments of which \$625,000 is set aside for payments on the mortgage.
- B. 2022 was a volatile year in both the stock and bond markets. We currently have 35% of our portfolio in stocks and the rest in short term bonds (Vanguard). Our investments were down 8% in 2022, while major stock indexes were down 13-19%, indicating effective management of church investments.

XI. New Business/Questions

Rodney was asked to review the condition of the organ. The organ has a solid state system to control the organ and it is almost to a point of failing. The projected cost of this repair is approximately \$55,000.

A motion was made by Tom Warman, seconded by Wanda Linebaugh, to adjourn. Unanimously approved.

SENIOR WARDEN REPORT

Greetings, Fellow St. John's Parishioners,

It has been a privilege to serve you as Senior Warden the past 12 months. In over 35 years as a member of St. John's, I have rarely been as optimistic for our future. In a fractious country and troubled world, we are building real community, striving to be a light to enlighten that world, as we attempt to model Christian love, formed in the image of God. At the bottom of every Vestry agenda is the reminder that in a Christian community, "we value people for who they are more than what they can do." I am happy to report that your Vestry takes that seriously, and we operate with graciousness and open minds as we find our way forward together, as stewards of the St. John's campus and financial resources, and partners in administration and ministry with Fr. Eric.

Thanks to the remarkable generosity of all of you, our budget is balanced, and our facilities are in outstanding condition. When visitors and prospective members join us, they find a campus that reflects pride of place and an effort to invest for the next generation. I was personally overwhelmed this year by the response to our request to help us refurbish Memorial Garden plaques and establish a fund to ensure the garden is a place of respect and respite well into the future. When we gathered one Sunday morning to rededicate it, I was reminded of the ties that bind – the many generations who have called St. John's home. As we stood in the garden together – many of us with family and all of us with parishioners we knew whose ashes are interred there – it was a visible reminder of the connections between generations of members that goes well beyond simple friendship into a true Christian family. It made the connection for me between place and people.

And speaking of that connection, it is important not to substitute our financial health or the excellent condition of our buildings for community and spiritual health. That health comes from worshipping, learning, and working together for the increase of God's kingdom. We are extraordinarily blessed to have a Rector who blends vision, management skills, intellect, pastoral sensitivity, and good cheer in the way Father Eric does. Thanks to his leadership, there are green shoots of growth in our membership. That is no small statement at a time when most traditional churches – including, unfortunately, many of our fellow Central Pennsylvania Episcopal churches – are struggling to find relevance to the modern world. We should never take great leadership for granted. The Vestry is in an ongoing discussion about how we can make sure Father Eric has the help he needs to help all of us live fully into our faith in whatever manner is most important to us. We take that need very seriously.

Finally, it is true that we need to have a plan by the end of 2024 to retire what will remain of our mortgage when current funds reserved for that purpose are exhausted in 2026. The Vestry has commissioned a small group to study our options, and report back to the Vestry this summer. Given our history, I do not personally have any concern that we will meet the moment, but it will not happen by magic. It will happen because we will plan ahead and apply the professional expertise of many of our members, and the vision and generosity of all.

Thanks again to Father Eric, my fellow Vestry members, and all of you for making the role of Senior Warden at St. John's meaningful and easy – it truly is a pleasure to serve in that capacity at a place that means so much to me.

JUNIOR WARDEN REPORT

As we move forward into 2024, we look back and see what a productive year 2023 was. There were many projects which were completed and new projects placed on the slate for 2024.

First, we completed the installation of the new HVAC system in the sanctuary. I am sure we can all agree it was a welcomed completion. The second major improvement, thanks to Claudia Parks and her fellow associates, was the installation of our refurbished historic entrance. The completion was both a welcomed beautification, plus an added safety factor. JOB WELL DONE.

Another project completed for safety reasons was the removal and resetting of the flagstone steps both in front of the entrance to the Commons area and the steps leading into the courtyard. Over the years these steps had become loose and caused a safety factor. As this project was being done there was also work being done on the church building itself. Mortar repair and outside sealing of the brick to prevent moisture from seeping into the interior walls. This project is still ongoing with a completion scheduled for spring or early summer.

Another project completed was the patching and painting of the walls in the sanctuary, the commons area and also the parish hall. Once the painting was completed a committee was formed to reexamine the paintings which had been taken down and select paintings to be re-hung in the sanctuary. This has been completed until such time as additional paintings may be professionally cleaned and restored.

Finally, I could not end this report without expressing the sincere gratitude I feel for our sexton, Shawn Lauer. His dedication to this facility is unsurpassed. He handles many of the situations occurring and addresses the problems before they become major concerns. His association with many of the outside contractors is amazing. Most of the time his calls are answered almost immediately. He is certainly a valuable member of the team.

I would also like to take this time to thank all the members of the church for the support you have shown in my years as Junior Warden. It has been a very rewarding journey. THANK YOU and GOD Bless.

TREASURER REPORT

Once again in 2023, as it has since 2018, the parish was able to conduct its normal operations based on budgeted income from pledged and non-pledged contributions, parking lot and facility rental income, and fund raisers. No investment funds were needed to balance the budget and, thanks to generous giving by our parishioners, out of total expenses of \$589,289 we ended the year with a \$12,642 surplus.

As shown in Figure 1, the church structures its finances so that Operations and Property are treated as two separate financial entities so as not to comingle resources. Figure 2 is a breakdown, in pie chart form, of the major elements of the 2024 Operating Budget indicating that it is a balanced budget as required by the church's bylaws. The church's primary financial goals continue to be those shown in Figure 3.

Thanks to diligent vestry leadership, the church has been able to address a wide range of property maintenance needs in recent years, ranging from the preservation and protection of our most fragile stained glass to urgent masonry repairs that have preserved the integrity of our sacred structures. We are blessed that overall, our property is in very good shape and works for us and not the other way around. However, given the age and size of our facilities, we maintain an ongoing list of property maintenance projects that are addressed as funds permit or urgency dictates. This list is shown in Figure 4 as either priority (1 to 3 years) or long range (4 or more years). One-time special donations targeted at one or more of these property maintenance needs are always welcome and greatly appreciated.

Details about the church's mortgage that financed the property improvements that were made several years ago are shown in Figure 5. Thanks to the parish's response to two capital campaigns plus a number of generous unexpected additional donations and two loan restructurings over the past several years, we have made great strides in paying down the mortgage. Of note is the fact that 23% of the original loan balance has been retired by non-scheduled principal only payments. As Figure 3 indicates, one of our primary financial goals is to develop and implement a mortgage retirement plan. The vestry, with the help of the Stewardship and Finance & Investment Committees, is continuing this year to actively explore options to accomplish this goal.

The overwhelming success of this year's pledge campaign, coupled with running budget surpluses for a number of years in a row, and the number of unexpected and unplanned donations the church has received recently toward property maintenance and improvement projects and paying down the mortgage should give us all confidence that the financial health and well-being of the church is strong and resilient and will continue so as we look to the future.

Finally, many thanks to those who serve on the Stewardship and Finance & Investment Committees, to our excellent Financial Administrator, Cathy Sowers, and to the rector and vestry for all of their diligent efforts in keeping our finances on a very sound and sustainable footing.

St. JOHN EPISCOPAL CHURCH 2024 FINANCIAL STRUCTURE

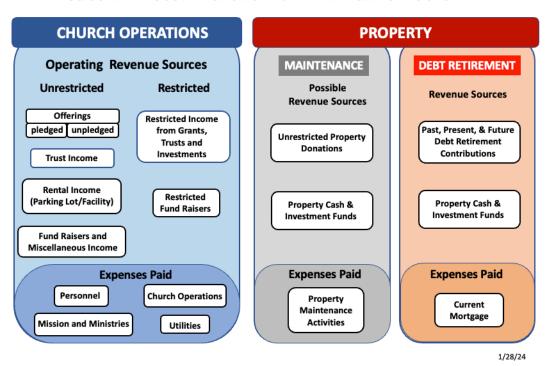
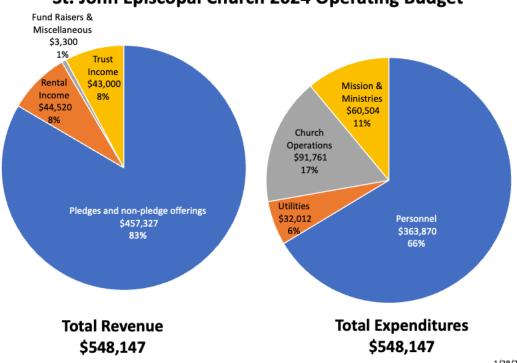

FINANCE AND INVESTMENT COMMITTEE REPORT

The Finance and Investment Committee met twice during 2023 to oversee the financial issues of the Church and conducted one e-vote. The individuals on the committee are the Rev. Eric Hillegas, Eric Menzer, Liz Wright, Cathy Sowers, Vicki Kearns, Pete Partridge, Milton Leake, Morgan Hively.

The main items addressed during the year were raising sufficient funds from the Property Investment Account to fund the mortgage payments, safeguarding the Property Fund to preserve capital, the status of the Restricted Fund and creating a 2024 budget for the Vestry to approve (covered in the Treasurer's report).

Given that all funds in the Property Account will be used by August 2026 to cover mortgage payments, it is becoming more imperative that capital be preserved. The Committee voted in February to sell all shares out of the two smaller stock funds and the Intermediate Bond Fund. With rising rates in money market accounts, the committee opted to move all funds into a Money Market. It was determined that PeoplesBank offered much higher rates than Fulton, so the funds were kept there. Also, because of the higher interest rates in the MM account, the Committee voted to move funds in the Operating Cash Reserves to a MM account. At the second meeting in October, the committee voted to sell the remaining stock fund and significant shares out of the two short term bond accounts. The committee initially determined to place those funds in the MM account. But a later discussion concerning the ability to lock the interest rates by using CDs resulted in an E-vote to place a majority of those funds into three short term CDs which will cover mortgage payments halfway through 2025.

The second main item on the Committee's 2023 agenda was the status of Restricted Funds. Restricted Funds are those in which the donor has given instructions for the use of the money. The money currently in the Fund has been there for decades and somewhere along the way, the instructions for the intended uses has been lost. Over the spring and summer, Liz undertook a physical examination of the Vestry minutes going back to 2000, along with requesting statements from PeoplesBank going back to 2011 (the earliest date available). The review was unable to shed any light on the remaining money in the account. During 2015, a significant portion of the then current balance was used towards the church's renovations, as the funds in the account were deemed to have "limited restrictions". It was agreed that any gifts are of an age that no one is around to authorize them being put to another purpose. A recommendation was made that Eric Menzer draft a proposal for the Vestry to vote on allowing the funds to be used for other purposes as determined by the Vestry.

LAY EUCHARISTIC MINISTERS, LECTORS AND USHERS

Lay Eucharistic Ministers (i.e "chalicers") assist the clergy in the administration of communion and lead the Nicene Creed at the 8:00 and 10:00 services, as well as at special services throughout the year, including Holy Week and funerals. In addition, Lay Eucharistic Ministers lead the Prayer of Intercession at the 8:00 service. Lay Eucharistic Ministers also serve as acolytes in the summer months at the 10:00 service. The chalicer group stands at 13 members with four additions this year, and two members on sabbatical.

Lectors are scheduled to read the appointed lessons at both services and lead the Psalm at the 8:00 service. A lector also leads the Prayers of the People at the 10:00 service. One Lector is appointed weekly for the 8:00 service and three for the 10:00 service. A total of 18 parishioners now serve in this capacity, an increase of one member from last year. More volunteers would be welcome, especially at the 8:00 service.

Ushers assist at both the 8:00 and 10:00 service by greeting attendees, distributing service bulletins, and collecting alms. The ushers also present the gifts at the altar, keep a count of attendees, ring the bell, and straighten-up the church at the end of the service. Four ushers and an alternate are scheduled weekly. The usher corps stands at 22 members with the fortunate addition of a net five new volunteers in 2023.

2023 saw a much-welcomed response to requests for more volunteers, which eases the burden on all involved. It's an encouraging trend for the future of St. John's.
